Please print, carefully read the following form, and sign your name below. If you have any questions about your rights as outlined below, you should email us immediately.

Description of Program: China's Children International is launching a new project called "Humans of China's Children International (HCCI)!" This project will focus on adoptees from all over the world; their stories, their interests, their lives, and above all their uniqueness. Every adoptee has something special about them and it is through this project that their individuality (aside from adoption itself) can be shared globally. By participating in this project, each adoptee will be interviewed on a one-on-one basis about something ranging from simple and fun to something deep and meaningful. (i.e. What is your favorite childhood memory? What does family mean to you? What is your story?) Each adoptee will then submit a picture of him/herself, his/her family or something that represents who he/she is as a person. Please keep in mind that this project can be as personal or impersonal as you want, whether it is during the interview or submitting a picture. This project is supposed to be a fun way to represent our adoptee community!

Risks: The interviewee's profile and picture of choice will be posted publicly on the "HCCI" Facebook page, the CCI Instagram, and the China's Children International website (www.chinaschildreninternational.org) as a blog entry. CCI also retains the right in perpetuity to use the written profile and any accompanying images, in part or in whole, to promote CCI, its activities, programs, and community image on any platform and in any way it deems meaningful to its mission. Possible risks include: breaches of privacy, being exposed to content that makes you feel uncomfortable, interacting with people whose identity you cannot verify, and personal security.

There is also the possibility that you may feel uncomfortable or distressed while sharing your personal story (if chosen to) and while reading about or relating to discussions on adoption.

Terms and Conditions:

- 1. For your own safety, you may *not* reveal anything that is too revealing of your private life i.e. address signs, visible markers that could identify your home address, phone numbers, any personal passwords or log-ins, etc.
- 2. You are also prohibited from taking part in this project in ANY situation that may cause harm or bring danger upon yourself or others.
- 3. You absolutely may **NOT** reveal **ANY** inappropriate, mature, or provocative pictures or write or say anything inappropriate or provocative. This includes but is not limited to anything even remotely related to: hate speech, bullying, racism, sexism, homophobia, intolerance of any kind,

- any sort of sexual, sensual, or suggestive photos, and profanity or inappropriate language. If we see any sort of this behavior we will immediately revoke your access from the program.
- 4. Please be cautious of your own safety online remember that like any online programs, there are inherent risks involved with communicating with people that you do not know in real life. Do NOT give out any personal information. If you feel uncomfortable about anything, you are required to let a CCI board member AND an adult you trust know right away. You agree to our terms and conditions for participating in the program and you understand that your access to the program may be immediately revoked following any breaches of the signed agreement or at the indiscretion of the China's Children International Board. Additionally, you accept all risks and agree to accept FULL liability for any personal emotional or physical harm or damage that you may incur by participating in the program and release all CCI related volunteers of liability. You understand that participation in this program is entirely voluntary, and if at any time you do not want to participate anymore, you are free to withdraw at no costs. Finally, for anything that you submit for this project, CCI has the full rights to reproduce and redistribute the final project however we wish, including (but not limited to) promotional purposes and other forms of media.
